- ABRET 2021 Continuing Education Scholarship:** This \$1500 scholarship will cover one full registration to the 2021 ASET Annual Conference live event and \$1000 to cover travel and lodging to attend the conference. To be eligible for the scholarship, applicants must meet the ASET member qualifications, and must preparing to take an ABRET board exam for R. EEG T, R. EP T, CNIM or CLTM credentials.
- Cadwell 2021 Continuing Education Scholarship:** This \$500 scholarship will cover one Full registration to attend the 2021 ASET Annual Conference live event. To be eligible for the scholarship, the applicant must meet the ASET member qualifications, and must be preparing for the ABRET R. EEG T exam.
- Cadwell 2021 Continuing Education Scholarship:** This \$500 scholarship will cover one Full registration to the 2021 ASET Annual Conference live event. To be eligible for the scholarship, the applicant must meet the ASET member qualifications, and must be preparing for the ABRET CLTM exam.
- David Weaver and Company 2021 Continuing Education Scholarships:** Two \$700 scholarships are available. Each scholarship will cover the cost of one Full registration to the 2021 ASET Annual Conference live event **and** \$200 to be used by the recipient to offset travel expenses to the event. To be eligible for the scholarships, applicants must meet the ASET member qualifications.
- Lifelines Neuro Corp 2021 Continuing Education Scholarships:** Two \$500 scholarships are available. Each scholarship will cover the cost of one full registration to the 2021 ASET Annual Conference live event. To be eligible for the scholarships, To be eligible for the scholarship, the applicant must meet the ASET member qualifications, and must be preparing for an ABRET R. credentialing exam, and primarily working in EEG or LTM.
- Nihon Kohden America 2021 Continuing Education Scholarship:** This \$750 scholarship will cover the cost of one Full registration to the 2021 ASET Annual Conference live event **and** \$250 to be used by the recipient to offset travel expenses to the event. To be eligible for the scholarship, applicants must meet the ASET member qualifications.
- Ives EEG Solutions Continuing Education Scholarship:** This \$500 scholarship will cover travel and hotel expenses to fund the trip to attend the 2021 ASET Annual Conference. To be eligible for the scholarship, applicants must meet the ASET Scholarship Criteria, hold a current Neurodiagnostic credential and must provide a copy of flight purchase receipt and/or hotel bill documenting expenses, for a reimbursement check. Payment of meeting registration fee will be verified before funds are released to recipient.
- Spes Medica USA Continuing Education Scholarship:** This \$500 scholarship will cover travel and hotel expenses to fund the trip to attend the 2021 ASET Annual Conference. To be eligible for the scholarship, applicants must meet the ASET Scholarship Criteria, hold a current Neurodiagnostic credential and must provide a copy of flight purchase receipt and/or hotel bill documenting expenses, for a reimbursement check. Payment of meeting registration fee will be verified before funds are released to recipient.



- Elizabeth Mullikin Student Scholarship:** This \$250 scholarship covers one full student registration to the 2021 ASET Annual Conference. Applicant must be a student member of ASET for at least 6 months, and must be currently participating in an on-the-job Neurodiagnostic training program. Documentation of training status must be provided in a letter provided by the lab manager.



- ASET Scholarship.** You may use this form to also apply for an ASET Scholarship to attend the 2021 ASET Annual Conference live event by checking this box. Funded by the ASET Foundation, an ASET Scholarship covers the cost of one Full registration to the event. To be eligible for an ASET Scholarship, the applicant must be a member of ASET in good standing for at least one year prior to the year of submitting the application.
